# **DIRECTIONS**

## From I-15 North - Las Vegas Strip: (approximately 30 minutes)

- Follow I-15 to Exit 48 Craig Road.
- Exit onto Craig Road East (right turn).
- Follow Craig Road to the Main Gate/Visitors Center Nellis AFB (Craig Road dead ends at the Main Gate for Nellis AFB).
- As a reminder, our Event Access List (EAL) will not be posted at the Main Gate until 8:30 a.m. <u>Do not try to access Nellis AFB before 8:30 a.m.</u> You will be turned away.
- You do not have to stop at the Visitors Center. Please proceed directly to
  the gate in the far-right lane and be prepared to show your Drivers' License to
  the Gate Guard. Reference the "Event Access List (EAL) for the AFCEA
  Technology Expo at The Club".
- Once on base drive through the gate to the first stop sign and turn left to be on Fitzgerald Blvd in front of The Club.
- The Club is on Fitzgerald Blvd. and will be immediately on your right-hand side.

#### PARKING & PUBLIC TRANSPORTATION

Ample open parking is available at The Club. If you are facing the club the parking lot will be on the left-hand side. You can access The Club from this parking lot.

Public transportation such as Ubers, or Taxis, will not be allowed to access Nellis AFB.

### SHIPPING & EQUIPMENT INFORMATION

- You must present a REAL ID-compliant driver's license or ID. If your driver's license is not REAL ID-compliant please bring as U.S. Passport or Passport Card.
- If you are badged/have a CAC, or Retired Military with an ID Card, you do not have to be on our Event Access List.
- Please bring your Rental Car Agreement or Vehicle Registration, along with proof of insurance as you may be asked to show that you have these items in your possession.
